After such proposal, membership approval of a proposed amendment must be by not less than two thirds (2/3) a majority of the <u>owners of Lots subject to these Restrictions voting interests of the Association</u>. An amendment adopted by two thirds (2/3) vote of the voting interests of the Association <u>as set forth herein will be effective when an instrument reflecting the amendment is recorded within the Public Records of Citrus County, Florida.</u>
