DEED RESTRICTION AMENDMENT PROPOSAL PHASE III

Article VII Section 18 (a) 3. currently reads (text to be replaced is struck through):

The color, texture, style and general appearance of the proposed metal roofing material shall be compatible with the colors, standards and styles of the roofs installed in the community. The appearance of the proposed metal roofing material shall resemble, when installed, shingle, tile or shake roofs. Proposed metal roofing materials whose appearance, when installed, resembles vertical or horizontal flat panels (for example "barn roofs") are specifically prohibited.

PROPOSED CHANGE TO ARTICLE VII SECTION 18 (a) 3. (Bold and underlined)

The color, texture, style and general appearance of the proposed metal roofing material shall be compatible with the colors, standards and styles of the roofs installed in the community. The <u>proposed metal roofing shall not be of the corrugated / 2V type, or have a galvanized metallic finish.</u> Approved styles of metal roof include tile, shake, shingle, rib, or pan. Other styles may be requested for approval.
